

Pepperell Dam Removals

Pepperell's Ecological Resources

- Coldwater Fishery Resources
- Outstanding Resource Waters
- Squannassit Area of Critical Environmental Concern
- Nashua, Squannacook, &
 Nissitissit Wild and Scenic Rivers
- Home to native eastern brook trout and rare mussel and turtle species



Pre-Removal – Public Concerns

- Heard questions & concerns from the public
 - Historic
 - Flow in the river
- Sought out others who had been through dam removals to learn from their experience
- Visited sites of other dam removals...



Pre-Removal – Town Brook Site Visit

- Plymouth, MA
- 5 dam removals and 1 fishway
- Historic dams
- Learned about Native American pre-dam history
- Learned about ecological benefits





Pre-Removal – Preliminary Studies

- MA Div. of Ecological Restoration (DER) provides funding and technical assistance for Dam Removal Preliminary Design Services
 - Topographic and bathymetric surveys
 - Sediment testing analyses
 - Wetland resource assessments
 - Hydrologic & hydraulic modeling
 - Identification of potential impacts to environmental resources, infrastructure, historic resources, etc.
 - List of potential permitting requirements
 - Preliminary design plans and cost estimates
 - Memo summarizing above info and recommending next steps




Pre-Removal – Public Outreach

- Meetings with Conservation Commission and other town boards/commissions
- Presentations at local chapter of Trout Unlimited
- Outreach and presentations at local community centers
- Public site visits
- Town website



Pepperell Dam Removals – Overview



Turner Dam Removal

- High-Hazard, privately owned dam
- Historic site (mill building demolished)
- Only barrier on the Nissitissit River
- State-listed mussels
- Timeline:
 - 2011 Recon Study
 - 2015 Removal
- Reconnected 40 miles upstream to 57 miles downstream




Turner Dam Removal – Partner Efforts

- MA Div. of Ecological Restoration 2011 Reconnaissance Study
- Trout Unlimited Squan-a-Tissit Chap. Data loggers, leadership, volunteer efforts, funding
- MA Division of Fisheries and Wildlife Fish surveys since 2014, PIT tags
- MA Natural Heritage Program Study and translocation of rare mussels
- Keene State College (with funding support from TU) Pre- and post-removal sediment transport studies
- UMass Amherst Pre- and post-removal water quality studies (temperature & dissolved oxygen)












Turner Dam Removal – Partner Efforts







Keyes-Parker Dam Removal

- Non-jurisdictional dam within the town-owned Keyes-Parker Conservation Area
- Sucker Brook (coldwater fishery)
- Part of a larger ongoing connectivity restoration project involving multiple dam removals and culvert replacements







Ecological Restoration Projects

Wetlands Protection Act


- 1972: Wetlands Protection Act (MGL c.131§40)
 Authorized each city and town in MA to establish a locally appointed municipal agency (conservation commission) to plan for natural resource protection, acquire important land and water areas, and manage properties for conservation and passive recreation
- 2014: Amendment to Wetlands Regulations
 Established criteria for Ecological Restoration Projects to
 be eligible to receive a Restoration Order of Conditions
 (310 CMR 10.11 10.14)

Ecological Restoration Projects

- Projects whose primary purpose is to restore or otherwise improve the natural capacity of a Resource Area(s) to protect and maintain the interests identified in M.G.L. c 131§40, when such interests have been degraded or destroyed by anthropogenic influences
 - public or private water supply
 - groundwater supply
 - flood control
 - storm damage prevention
 - prevention of pollution
 - protection of land containing shellfish
 - protection of wildlife habitat
 - protection of fisheries
 - protection of the riverfront area
- Six project types including dam removal

Ecological Restoration Projects

310 CMR 10.13: Ecological Restoration Projects permitted by a Restoration Order of Conditions may result in the temporary or permanent loss of Resource Areas and/or the conversion of one Resource Area to another when such loss and/or conversion is necessary to the achievement of the project's ecological restoration goals



Typically, dam removals involve conversion of Land Under Water to Bordering Vegetated Wetland and associated reduction of buffers/Riverfront Area

Working with Conservation Commissions

Overview

- Understand their concerns
- Provide examples/resources
- Focus on the Wetlands Regulations
- Make it easy for them!

Understand their Concerns

- Conduct public outreach early
- Offer informational presentations to Cons Com and other boards/commissions
- Meet onsite!
- Understand that many Cons Coms have not worked on Ecological Restoration Projects
- Emphasize that restoration projects are NOT development projects
 - Projects are designed to maximize ecological benefit

Provide Examples/Resources

- Show example before/after pics from other dam removal projects (especially revegetation)
- Connect them with other Conservation Agents who have been through dam removals/ERPs
- Identify nearby completed or ongoing dam removal projects and encourage them to visit
- Point them to dam removal resources (last slide)
- Emphasize that project partners have been doing this restoration work at dozens of sites across the state for many years with great success

Focus on the Regulations

- Educate them about Ecological Restoration Projects and Restoration Orders of Conditions
 - Restoration OOC includes general conditions and special conditions for dam removal projects
 - Cons Coms can only issue additional conditions under their bylaw/ordinance
- Refocus them on their jurisdiction if necessary
 - Wetland resources—not historic, aesthetics, etc.

Make it Easy!

- Reassure them that other agencies conduct extensive reviews and address major issues (e.g., WQ, water supply, sediment, invasives, monitoring, etc.)
 - DEP, DFW/DMF, NHESP, DCR, USACE
- Spell out exactly how the project meets Ecological Restoration Project criteria and WPA Performance Standards
 - Fish Runs, Banks, Bordering Vegetated Wetlands, Land under Water Bodies and Waterways, Land Subject to Flooding, Riverfront Area

Summary

- Pictures are worth 1,000 words
- Site visits are invaluable
- Wetlands Regulations have paved a pathway for these restoration projects
- Trust in the state/federal permitting process
- We all want the best for the wetland resources!
